

Official Rules for Adelman Broadcasting “Salsa Saturday” contest:

HOW TO ENTER: No purchase necessary. To enter your salsa, call 661-718-1552 during regular business hours, Monday through Friday, 9am - 5pm.

PRIZE: 4 tickets to LEGOLAND tickets-(Choice of legoland, Sealife or Legoland water park) tickets is for one of these Carlsbad, California, and \$200 spending cash. The Legoland tickets are not redeemable for cash.

DATE AND TIME OF SALSA CONTEST:

Saturday, April 22th, 2017. Contestants should arrive at least one hour before 1pm prep start time. The Poppy Festival hours are 10am - 6pm.

LOCATION OF SALSA CONTEST:

Lancaster city park at the north side baseball field during the 2017 California Poppy Festival.

GUIDELINES:

1. Salsa prep time is from 1pm - 3pm. All entered salsa must be prepared on site during the designated prep time.
2. Contestants must bring all necessary items including extension cords, utensils, cutlery, blenders, hot plates, chips, cutting boards, wash tub, and any other necessary items needed to prepare the salsa.
3. Contestants must wear gloves which will be supplied by Adelman Broadcasting.
4. Judging will take place immediately after prep time has ended.

Electrical power will be supplied. Cleanliness counts.

JUDGES: Appointed and provided by the City of Lancaster Parks & Recreation Department.

AWARDING OF PRIZE: Prizes will be awarded on site after a winner has been determined by the judges.

ELIGIBILITY: The "Salsa Saturday" contest is open to all legal residents of the United States and its territories, 18 years of age or older with a valid California driver's license as of the time they enter the contest within the station broadcast signal areas. Internet listeners outside the station broadcast areas are not eligible. Void where prohibited, taxed or otherwise restricted by law. All federal, state, provincial and local laws and regulations apply.
